The meeting started with recitation of the verses from the Holy Quran by Mr. Akhtar Hossain, Member of Executive Committee.

Mr. Md. Nadimul Haque, Member of Parliament, President of The Muslim Institute chaired the Meeting.

Agenda No.1: Confirmation of the Minutes of last Annual General Meeting.

Md. Shamsus Saleheen, the Education Secretary read out the minutes of the last Annual General Meeting.

It was unanimously approved by the members.

Agenda No.2: Business arising therefrom:

Nothing came up for discussion.

Agenda No.3: Hony. General Secretary's Report for 2022-2023.

Md. Nooruddin, Hony. Library Secretary, read out the Hony. General Secretary's Report for the year 2022-2023.

Agenda No. 4: Approval of Audited Accounts for Financial year 2022-2023.

Dr. Dabir Ahmed, Hony. Treasurer, read out the Audited Accounts for Financial year 2022-2023.

It was unanimously approved.

Agenda No. 5: Appointment of Auditor for Financial year 2023-2024.

Dr. Nayeem Ahmed, Hony. Assistant General Secretary, proposed the name of **M/s. M. Ali Raza & Company as the Auditor for Financial Year 2023-2024.**

Dr. Dabir Ahmed, Hony. Treasurer seconded his proposal. The members approved the name of **M/s. M. Ali Raza & Company** as the Auditor for Financial Year 2023-24.

Agenda 6: Miscellaneous

a) Mukhtar Ali - Life Member.

- i) He proposed that The Muslim Institute should approach the government departments and public representatives for financial assistance.
- ii) The process of availing Tax exemption under section 80G for The Muslim Institute should be expedited. He assured of all help in this regard.
- Iii) The activities of The Muslim Institute should be expanded to different areas. It should strive to become a centre for the guidance of the students of the community.

b) Sk. Shamsul Haque-Senior Member

- i) The activities of the Institute should be made familiar to the people of other districts of the state.
- ii) The banner, notice or other advertisement materials should include Bengali language also.
- iii) Among the members of the Institute the number of Bengali speaking persons is very less. Steps should be taken to increase the number of Bengali speaking persons.

c) Ali Akbar-Senior Member:

He proposed to create a section for Health care activities. The Muslim Institute should organize Health camps, Eye Check up Camps etc.

d) Azhar Imam - Senior Member:

i) The Library of the Institute should be made more user friendly. If required, more amount may be spent on improving the facilities and increase the stock of books.

e) Rashed Nehal Siddiqui-Life Member:

- i) The matter of inclusion of women as a member of The Muslim Institute was pointed in the previous A.G.M. What is the progress in this regard?
- ii) There is a need of a wash room for the girls of coaching classes and library. In response to the matters raised by the members, the Hony. General Secretary took the mike to reply to their queries. He said that despite his ill

health he had come to attend the meeting in order to meet the members and interact with them.

In connection with the matter of getting grants from the Govt. of West Bengal, he informed the members that a sum of Rs. 50 lakh had been sanctioned by the MA&ME Department, Govt. of West Bengal for the construction of Light Roof Structure.

After submitting all the required papers and meeting the officials in person, several times, a sum of Rs. 17,67,440 was released.

Meanwhile, the necessity of installation of lift was felt by the members. It was decided that the work should be done on a priority basis. All efforts are being done to get the remaining fund from the MA&ME Department and get funds from other members of Legislative Assembly and Parliament.

The matter of Tax exemption under 80G is being pursued with urgency. The newly appointed Auditor is consulted in this matter and he has assured that he will get the work done expeditiously.

The General Secretary addressed the concern of the member and assured that the banner of next A.G.M. will include Bengali. He further said that the Institute has a good percentage of Bengali speaking persons. Many sectional secretaries and one Asst. General Secretary are Bengali speaking. The Institute has no policy of encouraging or discouraging any particular section from becoming a member.

The proposal of Ali Akbar Saheb is very good. In fact we had taken initiative to organize Health Check up Camp but due to some reasons the plan could not be given the final shape. But we will certainly take up the matter of Health programme in future.

Regarding proposal for the inclusion of women members in The Muslim Institute, the previous Constitutional Amendment Committee held several meetings and came out with its proposals. The matter could not be pursued further as the Constitutional Amendment Committee could not sit for further meetings.

The new Constitutional Amendment Committee under the Chairmanship of Mr. Amiruddin (Bobby) will look into the matter.

Meanwhile, two important personalities who came to attend the A.G.M. were invited to share their thoughts.

Intaj Ali Shah, former Chairman, Minority Commission, West Bengal, suggested that the under privileged section of the community should be

empowered to stand on their feet and face the adversities in their life. This can be done by imparting education and guidance to them.

Ahamed Hassan Imran, the Chairman of the Minority Commission recounted the glorious past achievements of The Muslim Institute. Many stalwarts and thinkers of Bengal were regular at The Muslim Institute. The Institute inspired thinkers and produced many intellectuals.

West Bengal has a Muslim population of 3.5 Crore. The Muslim Institute should try to reach out to as many persons as possible.

The Library section should approach the Library Minister Siddiqullah Choudhury for up gradation of the facilities. The books should be digitalised.

The Muslim Institute should strive to revive the interest of the people in the glorious history of the past. The contributions of Muslim thinkers & politicians should be made familiar to the people.

Md. Nadimul Haque, President, The Muslim Institute:

In his presidential speech, Jb. Md. Nadimul Haque congratulated the sectional secretaries and Executive Committee members for successfully carrying out programmes throughout the year. Still they must keep working and come out with innovative programmes for the society and the community in particular.

The Muslim Institute has recently organized a programme on Sahir Ludhianvi. A programme on Nawab Wajid Ali Shah should also be planned in future.

The Muslim institute should approach for collaborating with RICE for the coaching of the Minority students for competitive exams.

He informed the members that The Muslim Institute is going to host a felicitation Ceremony on the advice of the Chief Patron, Sri Sudip Bandyopadhyay, M.P. to honour and congratulate prominent Muslims appointed to various responsible posts. He invited all the members to attend the programme.

Friends, before I get into the details of our proceedings today, I would like to submit obituaries of few important personalities who have left for their heavenly abode during the session 2023-2024.

Janab Iqbal Ahmed, Former Vice President of The Muslim Institute, Former Deputy Mayor KMC and Former MLA expired on 31-05-2024. He was the architect of the present Executive Committee of The Muslim Institute. Relentlessly he fought against those who wanted to tarnish the image of the organisation. With his passing away, the Institute has lost a true well wisher, guide and a dedicated statesman.

Qari Md Ismail Zafar, Former Vice-President died on 27-03-2024. He contributed much to uphold the sanctity of this Institute and always played a supportive role for development as long as he was alive.

Sk. Sayeed Akhter, Former Gymnasium Secretary of the Institute died on 15-11-2023. He played very vital role in the development of the Institute till his last breath. Although he was a Cancer patient since long but he never expressed his anxiety and reluctance in the cause of his responsibilities. His passing away has tremendously created a void which is difficult to be fulfilled soon.

Sk. Hashmat Hossain, an Executive Committee member died on 20-06-2023. He was actively associated with the activities of the Institute and continued to do so till the day he expired. The institute held condolence meetings accordingly to pay respect to the departed souls.

Hon'ble members, I wish to request you all to observe 2 minutes silence for the departed souls and pledge to follow their footsteps to lead this organisation as per their dreams.

Friends, amongst a slew of programmes that took place during the session 2023-2024. I would like to mention some of them which are noteworthy and seems to be desirable to attract your attention.

1. Aamer Hussain, a star player of our Billiards Section who won bronze medal in

the 37th National Game held in Goa, on 23-10-2023. He was awarded a sum of Rs, 1 Lakh during a function at Dhano Dhanyo Stadium under Khela Shree Scheme by the Chief Minister of West Bengal, He was also offered a Govt job in West Bengal which is in the process to be finalised.

- 2. Arshad Zaman, another star player of Billiards and Snooker Section was awarded Rs 50,000 for winning the All India Snooker Championship held in Sam Billiards Club, Rajarhat last year.
- 3. Aamer Hossain made a break of 81in the just concluded six Red State Ranking Championship held in Calcutta Punjab Club. This is a national Record and Second highest record in the world.

This has of course raised the bar of Muslim Institute and added feather in the crown of the prestigious Institution. They deserve a big round of applause for their wonderful achievements.

On 23-03-2023, The Institute also arranged to organise a Job Fair with Mahindra Pride Class Room and Naandi Foundation with a view to help the unemployed females those of Muslim Institute and other centers to achieve job at different multinational companies. 10 such companies interviewed about 564 candidates and most of them were shortlisted for the Job.

The President of Institute and Shri Sudip Bandhupadhyay MP attended the Inaugural Ceremony, along with Mr. Debnath Boral, Regional Manager Operation of Nandi Foundation and his team.

The Drama and Music Section organised a program titled Yaad-e-Wajid Ali Shah, on 20-02-2024 in which Kathak dance was performed by Ms. Shruti Ghosh, It was attended by a good number of people from all walks of life.

A National Research Scholars Seminar and a Trilingual Fiction session along with Awards Ceremony were organized by Literary Sub Committee on 24-02-2024

On 09-12-2023, Teesta Setalvad, Noted Human Rights Activists and Journalists visited Muslim Institute and addressed a Seminar titled Human Rights, Humanitarian Laws in Modern Times.

Sir Syed Day Programme and Presentation of Sir Sed Ahmed Khan Award for Excellence was held on 17-10-2023. Hon'ble Justice Ashim Kumar Roy, Lok Ayukt, W.B attended as the Chief Guest, while Prof. Achin Chakraborty, Director, Institute of Development Education Studies, Kolkata delivered the Extension Lecture.

The Education Sub-Committee organized the Felicitation of the Successful

aspirants of WBCS and WBA& AS on 03-03-2023 A total of 15 such aspirants were felicitated. The Competitive Mind Quiz, Motivation and guidance drew participants from different districts of West Bengal.

Educational activities were given adequate emphasis aiming at the target to be achieved by the students. This is indicative of holding classes for recruitment in Police Service, Audit and Account Service NEET, WBCS and other recognised government jobs.

The Library section is functioning in full swing having facilities for fifty students, both males and females to help them prepare for different competitive exams.

Friends, overall development of the institute, of course lies in your unwavering support, which gave us inspiration to work hard.

In the end of my report. I would like to express my thanks and gratitude to our President Mr. Md. Many players from this section are now posted in various companies and railways in sports quota.

It is a matter of great pleasure that tremendous progress and development of the billiards section has taken place during the year 2023-24. Billiards hall is fully air conditioned and the playing conditions are of international standard. The activities carried out by this Sub-Committee during last one year are as under:

The Muslim Institute snooker league edition 3 took place this year. It's one of the most sought after tournaments every players look forward to participate in this league. A total of 10 teams took part in the said event, with a total of 40 top players. Blue Titans was the winner and Black Warriors finished as runner up. The prize distribution ceremony was graced by Mr. Nadimul Haque (Member of Parliament), President of the Muslim Institute, Mr. Parvez Raza, Chairman, Billiards Sub-Committee and the rest of the committee members.

Shoaib Khan took part in the pool National championship 2023 and finished as top 16 in the event. He also took part in the snooker and billiards national championship 2023 held in Chennai.

Aamer Hussain and Akram Khan represented West Bengal in the Billiards and Snooker respectively in the National Games 2023 formerly known as the Indian Olympics. Aamer Hussain finished as number 3 and won a bronze medal. For this remarkable achievement Mr. Aamer Hussain was felicitated and awarded cash prize by Gov. of West Bengal. West Bengal Billiards Association also felicitated Mr. Aamer Hussain for winning Bronze medal. This is the first time that a player from The Muslim Institute has won a medal in cue sports.

Aamer Hussain won the West Bengal State ranking championship 2023 which was held in Tollygunge Club. Akram Khan won snooker title at the said event. They both finished as Bengal no.1 in Billiards and Snooker for the year 2023 respectively.

Sk. Sarfarazuddin and Md. Saif Khan won the silver medal in the all India inter railway team championship 2023. Md. Saif Khan also finished as Bengal No.2 in the Snooker championship in the Tollygunge Club state ranking championship 2023.

In another event Mr. Arshad Zama won the Snooker state ranking championship 2024 which was held at Saturday Club this year.

More than 10 players from The Muslim Institute participated in the snooker and Billiards National Championship 2023 which was held in Chennai.

We are planning to hold an all India Snooker championship. Also in the plan is holding of an all India pool championship in the Muslim Institute.

The computer section of The Muslim Institute was established in the year 1999 when a humble beginning was made and some multilingual DTP computer centers were setup at select locations including Kolkata with the collaboration of NCPUL, Ministry of Higher Education, Govt. of India and NIELT, Chandigarh, Ministry of Telecommunication and Information Technology, Government of India. It was necessary that this technology is made available to the Urdu speaking population of the country with a view to transform them into employable technical workforce. Hence, the course comprising computer application, business accounting and multilingual DTP has been successfully running in the institute ever since it came into existence.

A number of students were awarded success certificates by NCPUL and NIELIT and it helped to achieve them jobs in both private and public sectors. The institute also arranged to organize a job fair with Mahindra Price Classroom and Naandi Foundation on 23.02.2024 with a view to help the unemployed females those of MI and other centers to achieve jobs at different multinational companies. Ten such companies interviewed about 564 candidates and most of them were short listed for the job.

Our president Mr. Md. Nadimul Haque, MP and Shri Sudip Bandhopadhyay, MP and Patron in chief of The Muslim Institute along with a number of people attended its inaugural ceremony at the Muslim Institute. Mr. Debnath Boral, Regional Manager, Operation of Naandi Foundation along with his team remained present at the institute till the completion of the interview process which was supervised throughout the day by the General Secretary Mr. Nisar Ahmed.

Individuals and organisations working in the field of education in Bengal are also felicitated to acknowledge their contributions and inspire others.

The Education Sub Committee carried out its proposed programmes which were greatly beneficial for the students and were highly appreciated by all.

The details of the activities and programmes conducted by the Education Sub Committee during the period of April 2023 and March 2024 are being given below for the perusal of the members.

- 1. A Counselling Programme for the H.S 2023 passed students about the choice of subjects and admission process in various the Colleges was organised on the 1st June 2023. The students were apprised about the various stages of admission process and how to make the choice of subjects for the graduation course. A large number of students got benefitted by this counselling programme.
- 2. A Career Counselling programme titled "Career in Law and How to Prepare for LLB" was held in the Mohsin Hall of the Muslim Institute in association with SAKET on 9thJune2023. Dr Sarfaraz Ahmed Khan, Associate Professor, WBNUJS, a man on the mission to create awareness about career in law, explained in details the various avenues a law graduate can explore. Two other advocates from SAKET, Shama and Kulsum,informed the students about Law Colleges under Calcutta University and how to prepare for the entrance test for the LLB course. Advocate Jahan Ara,a former student of the MI coaching,was also present. The speakers answered the queries of the enthusiastic participants in the end.
